ACCEPTABLE USE POLICY

This Acceptable Use Policy (“AUP”) governs your access to and use of websites operated by Merito Solutions, Inc. and its affiliates (“Merito,” “we,” “us,” or “our”), including any forums, blogs, customer support areas, or other publicly available online services or interactive features (collectively, “Our Websites”).
